GROUP BOOKINGS TERMS AND CONDITIONS

Thank you for booking your private event at Estate Vaucluse House. We look forward to working with you to ensure it will be a lasting memory.

To ensure the most enjoyable experience for all guests, we ask group bookings to adhere to the following:

All members of a group booking must arrive and be seated within 15 minutes of the booking time.

COVID RESTRICTIONS

Due to Government restrictions, guests dining at the restaurant must remain seated and can't mingle. Food and alcohol can only be consumed while seated.

VENUE

Bookings within the Restaurant are non-exclusive.

DECORATIONS

We welcome decorations for your function. All decorations will need prior approval by management. Failure to advise management in advance of the function, may result in the decorations not being allowed at the Restaurant. Any decorations or changes to the aesthetics of the space are not allowed. Backdrops, confetti, scatters balloons, signs or similar are not permitted anywhere in the venue, including the grounds. If these items are used, a cleaning fee of \$200 + GST will be charged to you. Due to heritage of the building, no attachments are to be used on the walls and glass.

If you are bringing in your own decorations, you are responsible for the set up and pack down. Table activities must be undertaken in accordance with our health and safety policies.

EARLY ACCESS

Estate Vaucluse House will allow early access to your table 15 minutes prior to the commencement of the function for any decorations and other set up. If earlier access is required, prior approval needs to be made. Additional fees may be incurred.

CAKES

Estate Vaucluse House offers a selection of desserts that we can add candles to make your celebration special. We do not allow cakes or any other food or beverage to be brought onto the premises due to health and safety precautions. If a speciality cake is required, pre-approval is required by management. A cake fee will apply of \$3.50 per person.

QUIET ENJOYMENT POLICY

All guest dining at Estate Vaucluse House must agree to our quiet enjoyment policy. To be fair to all guests in our restaurant we ask that no loud noise or table activity [including games] that are likely to disturb other guests to be undertaken. Guests responsible for disturbance, noise or damage will be asked to leave the restaurant immediately. No refund will be given in these circumstances.

MUSIC

Restaurant music will be played during your event.

DEPOSIT

25% deposit is required to secure the booking.

This deposit is subject to our cancellation policy listed below.

CANCELLATIONS

Cancellation prior to 14 days of the event date, a full refund will be issued.

Cancellation within 14 days, but greater than 7 days of the event date will forfeit the 25% deposit.

If a booking is cancelled within 7 days of the event date, 100 % cancellation fee applies to the total event value of booking.

If the cancellation is made due to the NSW Government COVID-19 restrictions regarding restaurant and venue operations resulting in Estate Vaucluse House being unable to deliver the contracted services or reduced numbers, the following applies:

More than 4 days prior to your booking date and time, all monies will be transferred to your rescheduled date or refunded 4 days or less from your booking date and time, the 25% of the total booking value will be applied as cancellation as costs have already been incurred for your booking. Balance 75% payment will be transferred to the rescheduled date or refunded.

PAYMENTS

Final balance payment is due 7 days prior to your event.

DIETARY REQUIREMENTS

Any dietary requirements are to be confirmed no less than 7 days prior to your booking.

FINAL GUEST NUMBERS

Guest numbers are to be confirmed no less than 7 days prior to your booking, changes within this time will be charged at the full amount at the time of reservation.
